

Our Home is Your Home Sweepstakes

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH INSTAGRAM, LLC, FACEBOOK, INC., OR TWITTER, INC.

1. Eligibility: Our Home is Your Home Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia and Canada (excluding the province of Quebec) who are at least eighteen (18) years old or the age of majority in their state, province or territory of residence at the time of entry (except nineteen (19) years in Alabama and Nebraska, and twenty-one (21) years in Mississippi). Employees of Wyndham Vacation Rentals North America, LLC, ("Wyndham Vacation Rentals") Chute Corporation., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, provincial, and local laws and regulations and is void in Quebec and where prohibited. 3. Timing: The Sweepstakes begins on August 19, 2017 at 12:00 a.m. Eastern Time ("ET") and ends on October 31, 2017 at 11:59 p.m. ET (the "Promotion Period"). Administrator's computer is the official time-keeping device for the Sweepstakes.

4. How to Enter: During the Promotion Period, visit WVROurHomelsYourHome.com, and follow the links and instructions to complete and submit the registration form or tag your image on Instagram with #WVROurHome. You automatically will receive one (1) entry into the Grand Prize Entry Period drawing for registering and on each day you subsequently login.

Any entry (including a photo or other content) must be in keeping with Sponsor's image and may not be inappropriate, indecent, provocative, sexually suggestive, obscene, pornographic, hateful, tortious, defamatory, or libelous or contain material that violates or infringes another's rights (including but not limited to privacy, publicity or intellectual property rights, or constitute copyright infringement), or disparage Sponsor or any other person or party affiliated with the Sweepstakes, or contain material that is unlawful in any way.
